## 2024 Kubota Hometown Proud™ Official Rules

## NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

- **1. ELIGIBILITY:** The Kubota Hometown Proud™ promotion (the "Promotion") contains a contest of skill (the "Contest") and a sweepstakes (the "Sweepstakes") that is administered via the voting portion of the Promotion. The Contest is open only to the designated representatives of 501(c)(3) nonprofit organizations, in viable financial standing (as determined by Sponsor in its sole discretion), which are located within 50 miles of an authorized Kubota dealer to qualify. The designated representative, and each entrant into the Sweepstakes must be a legal resident of one of the fifty (50) United States or the District of Columbia, and at least eighteen (18) years old (except Alabama and Nebraska 19 and 21 in Mississippi) at the time of Promotion registration. Employees, officers and directors of Kubota Tractor Corporation (the "Sponsor"), and any of its subsidiaries and affiliates, previous 2021, 2022 and 2023 promotion winners including Bexar County Junior Livestock Show, Wayne County Ag Center, Camp Character City of Willard, Missouri, Westside Ministries Food Literacy Program, Food Bank of Monterey County, Rancho Brazos Community Centers, New Richmond area Community Foundation, Homesteads for Hope Community Farm, Langton Green, Inc. The Giving Grove, Black Farms, Food, and Families Project, Lucasville Community Park, The Children's Village, Hunger Task Force, Realtime Media LLC (the "Administrator"), Fleishman-Hillard Inc., and each of their respective parent companies, affiliates, subsidiaries, advertising, and fulfillment and marketing agencies, (collectively, "Promotion Parties") their immediate families (parent, child, sibling & spouse and their respective spouses, regardless of where they reside) and persons living in the same households as such individuals (whether related or not) are not eligible to participate in the Promotion. By participating in the Promotion, you release, discharge and hold harmless Promotion Parties, their respective parents, affiliates, subsidiaries, retailers, advertising and promotion agencies and the respective officers, directors, employees and agents of each of the foregoing, from any and all damages whether direct or indirect, which may be due to or arise out of participation in the Promotion or any portion thereof, or the acceptance, use/misuse, or possession of any prize. By participating, you agree to these Official Rules and to the decisions of the judges and Sponsor, which are final and binding in all respects. Void where prohibited by law, rule, or regulation. - **2. TIMING:** The Promotion begins at 12:00:01 a.m. Central Time ("CT") on March 1, 2024, and ends at 11:59:59 p.m. CT on September 10, 2024 ("Promotion Period") and will consist of three (3) phases, as detailed below:
  - **Contest Entry Period:** Begins at or about 12:00:01 a.m. CT on March 1, 2024, and ends at 11:59:59 PM CT on April 12, 2024
  - **Public Voting Period (and Sweepstakes Entry):** Begins at or about 12:00:01 a.m. CT on August 1, 2024, and ends at 11:59:59 p.m. CT on August 14, 2024
  - **Winner Announcements:** The twenty (20) grant finalists (for public voting to determine the grant recipients) (each a "Finalist") will be announced publicly on August 1, 2024 when the voting period opens. The ten (10) grant recipients will be announced on or about September 10, 2024.

The computer clock of Sponsor is the official time-keeping device in the Promotion.

3. HOW TO PARTICIPATE IN THE CONTEST: To participate, if your organization is eligible per Section 1, above, and you are a designated representative, visit KubotaHometownProud.com (the "Website") during the Contest Entry Period to complete and submit an official Contest entry form (required fields include your Full Name and Email address and which one of the ten (10) "districts" your organization is in) with the true and correct information. Then, upload your application describing an upcoming necessary or desired project, on behalf of the applicable 501(c)(3) nonprofit organization or a municipality with a closely affiliated nonprofit 501(c)(3) organization, i.e. closely affiliated foundation or official nonprofit partnership, which must be located within 50 miles of an authorized Kubota dealer to qualify. You must also upload one (1) primary photo or video representing your proposed project and up to two (2) additional photos or videos. Accepted file types are; .jpeg, .png, .gif, .mp4, .mov, .wmv, Youtube links, and Vimeo Links. Maximum file size of 3MB. See judging criteria in Section 4, below, for guidance on how Contest Entries and applications will be judged. The Contest entry form and the application are collectively your "Contest Entry." Sponsor and/or Administrator will verify 501(c)(3) status and financial viability before winners are chosen. The person submitting the Contest entry form and uploading the application must be a designated officer or employee of the organization with the legal authority to act on the applicable organization's behalf, be authorized to submit the Contest entry, engage in all communications with Sponsor and/or Administrator regarding the Contest, and accept the prize on behalf of the organization, if selected as a recipient in this Contest.

## Limit of one (1) Contest Entry per organization and per designated representative throughout the Contest Entry Period.

By submitting a Contest Entry, you hereby grant permission for your Contest Entry to be posted on <a href="http://www.kubotahometownproud.com">http://www.kubotahometownproud.com</a> or other websites. You agree that Promotion Parties are not responsible for any unauthorized use of Contest Entries by third parties. Promotion Parties do not guarantee the posting of any Contest Entry. You agree that you will not use the Contest Entry for any other purpose, including, without limitation, posting the Contest Entry to any online social networks (other than for entry into this Contest), without the express consent of Sponsor in each instance.

By submitting a Contest Entry, you represent and warrant that the work submitted is original to you and that neither it nor its contents infringe upon or violate the rights of any third party. If your Contest Entry includes likenesses of third parties (such as, but not limited to makeup artist or subject) or contains elements not owned by you, (such as, but not limited to, company logos, other than those of your organization) you must be able to provide legal releases for such use in a form satisfactory to Sponsor or your Contest Entry may be disqualified. Contest Entries must not defame or invade the publicity rights or privacy of any person, living or deceased, or otherwise infringe upon any person's personal or proprietary rights.

**REQUIREMENTS OF CONTEST ENTRIES:** Contest Entries must not contain, as determined by the Sponsor, in its sole discretion, any content that:

- Is sexually explicit; unnecessarily violent or derogatory of any ethnic, racial, gender, religious, professional or age group; profane or pornographic; contains nudity;

By submitting a Contest Entry, you represent and warrant that your Contest Entry is original to you and your organization, that the Contest Entry has not been previously published, has not won previous awards and that neither it nor its contents infringe upon or violate the rights of any third party, including any copyrights, trademarks, rights of privacy, publicity, or other intellectual property. By submitting a Contest Entry, you warrant and represent that you consent to the submission and use of the Contest Entry in the Contest and to its use as otherwise set forth herein.

By submitting a Contest Entry, you acknowledge and agree that Sponsor may receive other Contest Entries in this Contest that may be similar or nearly-identical to the Contest Entry submitted by you, and you waive any and all claims you may have had, may have, and/or may have in the future, that any other Contest Entry reviewed and/or used by Sponsor may be similar to your Contest Entry and you understand that you will not be entitled to any compensation because of Sponsor's use of such other similar or identical material.

- **4. JUDGING:** Begins at 12:00:01 a.m. CT on April 12, 2024 and ends at 11:59:59 p.m. CT on June 30, 20, 2024. There are ten (10) "districts" and there will be up to two (2) Finalists per district selected via judging, then subject to public vote, as described below. The judging panel, selected by the Sponsor, will score each Contest Entry up to the maximum number of points allowed. Judging will be based on the following criteria:
  - Application clearly demonstrates the community's need for the project (25%)
  - Application provides a timeline for completion and identifies how use of funds would specifically be utilized within one year of receiving funding (25%)
  - Application states how the completion of the project will impact the community at large (25%)
  - Application identifies a connection to the local Kubota dealer, either through an existing relationship or justified need to build one, or specified type of Kubota equipment that could be used in the project. (25%)

Contest Entries that do not contain all required entry information or are considered inappropriate or incomplete for any reason are not eligible. The twenty (20) Contest Entries (two

- (2) per district) with the highest scores from the Judges will be deemed the potential grant Finalists, subject to public voting. In the event of a tie, the Contest Entry with the highest score in the application demonstrating the community's need for the community project criterion will be deemed the applicable Finalist. In the event of a double tie breaker the Contest Entry with the highest score in the application stating how the community will benefit long-term from the completion of the project will be deemed the applicable Finalist. After public voting, (see below) the one Finalist Contest Entry per district with the highest score from the Judges combined with the highest number of votes (see below) in its respective district will be deemed the potential grant winner for that district. In the event of a tie, the entry with the higher score in the application demonstrating the community's need for the community project criterion will be deemed the winner. In the event of a double tie breaker the entrant with the highest score in the application stating how the community will benefit long-term from the completion of the project will be deemed the winner. Sponsor reserves the right not to award all prizes or to choose fewer than twenty (20) Finalists and/or fewer than ten (10) grant recipients if, in its sole discretion, it does not receive a sufficient number of eligible and qualified Contest Entries. Prize awards are subject to verification of eligibility and compliance with these Official Rules.
- 5. PUBLIC VOTING & SWEEPSTAKES ENTRY: To vote, you must be at least the age of majority of your state of residence (18, except Alabama and Nebraska 19 and 21 in Mississippi) at the time of voting. Public voting begins at or about 12:00:01 a.m. CT on August 1, 2024, and ends at 11:59:59 p.m. CT on August 14, 2024. To place a vote, if you are eligible, during the Public Voting Period, visit the Website and follow the on-screen instructions to submit your name and email address (as well as any other required information), if you haven't done so previously, then place one (1) vote for your favorite Finalist. By registering and submitting a vote, you will receive one (1) entry into the Sweepstakes drawing of the Promotion ("Sweepstakes Entry"). You may login and vote one (1) time per day during the Public Voting Period and will receive one (1) Sweepstakes Entry for each time you do so. All entrants and all organizations are prohibited from obtaining votes by any fraudulent or inappropriate means, including, without limitation, offering prizes or other inducements to members of the public, as determined by Sponsor in its sole discretion. Votes generated by script, macro, or other automated means or which subvert or impair the integrity of the voting process will be void. Any attempt to exceed the limited number of votes, shall give the Sponsor the right to void the votes in question and disqualify the Contest Entry, and any associated Sweepstakes Entries, in its sole discretion. Limit of one (1) vote and one (1) ("Sweepstakes Entry") per person, per email address, per day, throughout the **Public Voting Period.** For purposes of this Promotion a "day" is understood to mean 12:00 a.m. CT through 11:59 p.m. CT.
- **6. SWEEPSTAKES DRAWING/ODDS:** On or about August 21, 2024, the Administrator will conduct a random drawing from all eligible Sweepstakes Entries received during the Public Voting Period. Odds of winning depend on number of eligible Sweepstakes Entries received in accordance with these Official Rules. Sponsor cannot predict the number of Sweepstakes Entries.
- 7. WINNER NOTIFICATION: Prizes will be awarded only upon winner redemption, confirmation, verification, and final approval by Sponsor. No substitution, transfer of any prize or cash alternative permitted, except by Sponsor who reserves the right, in its sole discretion, to substitute a prize of equal or greater value, if prize, or portion of prize, becomes unavailable. Sweepstakes: The potential Sweepstakes Prize winner will be notified by email and required to complete and submit a declaration of eligibility/release of liability/prize acceptance agreement ("Declaration"), within three (3) days of date of notification, as a condition of receiving the Sweepstakes prize. If any potential prize winner fails or refuses to sign and return the Declaration

within the required time period or if the Declaration is returned as rejected, faulty, unclaimed or returned as undeliverable to potential winner, and/or the potential winner is otherwise noncompliant, the potential winner will be disqualified and an alternate will be selected in a random drawing from among all eligible non-winning Sweepstakes Entries received, up to three (3) alternates, after which the Sweepstakes prize will remain un-awarded. Contest: The designated representative of each of the potential Contest Prize winners (Finalists and Grand Prize winners) will be required to complete and submit a declaration of eligibility/release of liability/prize acceptance agreement ("Declaration"), within three (3) days of date of notification, as a condition of receiving a Contest prize. If any potential prize winner fails or refuses to sign and return the Declaration within the required time period or if the Declaration is returned as rejected, faulty, unclaimed or returned as undeliverable to potential winner, and/or the potential winner organization is otherwise noncompliant, the potential winner organization will be disqualified and an alternate may be determined based on the judging scores and votes described above. A potential winner becomes a "Winner" only after verification of eligibility by Sponsor. All prizes will be fulfilled in approximately eight (8) to twelve (12) weeks after the Promotion has ended. Grant Finalists will be announced for voting on or about August 1, 2024. Grand Prize and Finalist grant winners will be announced on or around September 10, 2024.

No more than the stated number of prizes will be awarded. If, for any reason, more bona fide winners come forward seeking to claim prizes in excess of the number of each type of prize set forth in these Official Rules, the winner(s) of the advertised number of prizes available may be selected (for the Sweepstakes) in a random drawing from among all persons making purportedly valid claims for such prize or for the Contest, using the judging and votes as described above. Inclusion in such process shall be each entrant's sole and exclusive remedy under such circumstances.

**8. PRIZES/PRIZE RESTRICTIONS:** A total of twenty-one (21) prizes will be awarded during the Promotion, 10 for Grand Prize winners of the Contest (1 per district), 10 for Finalists who did not win a Grand Prize (1 per district) and one (1) Sweepstakes prize for voting.

**TEN (10) CONTEST FINALIST PRIZES:** Ten (10) Contest Finalist Prizes will be awarded to the Finalists who were not awarded a Grand Prize in the Contest, in the amount of \$10,000 each. Approximate Retail Value ("ARV") of each Finalist Prize is \$10,000.

**TEN (10) CONTEST GRAND PRIZE WINNER PRIZES:** Ten (10) Grand Prize winners (1 per district), will be awarded. The Finalist with the most votes and highest score in each of the 10 districts will receive a Hometown Proud \$50,000 grant. The ARV of each Grand Prize is \$50,000.

The ARV of all of the Contest prizes is \$600,000.

**ONE (1) SWEEPSTAKES PRIZE:** Winner's choice of one (1) Kubota zero-turn mower or one (1) Kubota BX sub-compact tractor.

The ARV of the Sweepstakes Prize is \$10,000.

## The Total ARV of all Promotion prizes is \$610,000.

Winner(s) will be solely responsible for all federal, state and/or local taxes, and for any other fees or costs associated with the prizes received, regardless of whether they, in whole or in part, are used. The ARV of the prizes is based on available information provided to Sponsor

as of the time these Official Rules are printed and may fluctuate. The value of any prize valued at \$600 or more awarded to a winner will be reported for tax purposes as required by law. The winner of such prize will be required to provide Sponsor with a valid social security number before the prize will be awarded for tax reporting purposes. An IRS Form 1099 will be issued in the name of winner for the actual value of the prize received. Any unclaimed prize will be forfeited. Prize(s), if legitimately claimed, will be awarded.

- 9. PRIZE LIMITATIONS: Limit of one (1) prize per organization and per person or household. Contest Prize winners are NOT eligible to receive a Sweepstakes Prize. If it is discovered during prize verification you have entered, attempted to enter, or used multiple accounts to enter either the Sweepstake or the Contest more than the stated limit, you will be disqualified at the discretion of the Sponsor and/or Administrator, and/or your entries will be void. Entries of any kind generated by script, macro, or other automated means, which subvert the entry process, are void. By submitting a Contest Entry, you consent to completing a form and providing progress pictures, if you are selected as a Finalist or Grand Prize winner, on the Sponsor's schedule (\*Subject to change\* required months: January, May, and September 2025). By submitting a Contest Entry, you consent to the use, by Sponsor, its affiliates, subsidiaries, parents, and licensees, of your name, likeness, and image, in connection with this Promotion and Sponsor's related marketing activities, in any media or format now known or hereafter invented, in any and all locations, without any payment to or further approval from you. You agree that this consent is perpetual and cannot be revoked. For uses beyond the consent that you grant above, you agree that Sponsor's use of your personal data will be governed by the Privacy Policy posted on the Sponsor website and in Section 12, below.
- **11. GENERAL PRIZE CONDITIONS:** Prizes will only be awarded by Sponsor upon potential winners' verification of eligibility and final approval by Sponsor. No prize substitution, cash equivalent of prizes, transfer or assignment of prizes is permitted, except by Sponsor which reserves the right to substitute a prize with one of comparable or greater value, in its sole discretion.
- 12. MISCELLANEOUS: Promotion Parties are not responsible for late, lost, incomplete, corrupted, stolen, garbled, damaged, delayed, undelivered or misdirected entries, all of which are void. Entries will be considered to be entered by the authorized account holder of the email address submitted at time of entry and that individual must comply with these Official Rules. The authorized account holder is deemed as the natural person who is assigned to an email address by an Internet access provider, online service provider or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address.
