

## Built by You Second Chance Sweepstakes Official Rules

The Built By You Second Chance Sweepstakes (the “Sweepstakes”) is subject to the full Official Rules of the Built By You Contest (the “Contest”) offered by Kubota Tractor Corporation (the “Sponsor”) and the terms set forth below. By participating in the Sweepstakes as set forth herein you are bound by the Contest Official Rules, which incorporate Entrant eligibility and conditions for entry, and these Sweepstakes Official Rules.

- 1. SWEEPSTAKES OVERVIEW:** Participation constitutes participant’s full and unconditional agreement to and acceptance of the Contest Official Rules as well as these Sweepstakes Official Rules. The Built by You Second Chance Sweepstakes (“Sweepstakes”) begins June 1, 2026 and ends at 11:59 a.m. CT on August 24, 2026 (“Sweepstakes Period”). The Sweepstakes is administered by Realtime Media LLC (“Administrator”).

This Sweepstakes is available to all eligible participants who submit an Entry into the Contest in compliance with the Contest Official Rules. All non-winning Entries submitted into the Contest will be automatically entered into this Sweepstakes. If your Entry did not win in the Contest, you will receive one (1) entry into the Sweepstakes. Entrants who are disqualified from the Contest in Sponsor’s sole discretion, as further described in the Contest Official Rules, will also be automatically disqualified from the Sweepstakes (together, an “eligible entry”). Any entries from ineligible participants will be null and void.

SWEEPSTAKES DRAWING:** On or about September 1, 2026, the Administrator will conduct a random drawing to select one hundred (100) potential Sweepstakes winners from among all eligible non-winning Entries received in the Contest and in accordance with these Official Rules. As part of the Sweepstakes winner notification process, each potential Sweepstakes winner will be required to complete and return a prize redemption form (“Redemption Form”) within three (3) days of date of notification, as a condition of receiving a prize.
